For my entry in Girl Scouts' "Family Fun Run" to be held on Sept. 18, 2010, I attest that I am physically fit, have sufficiently trained for and am mentally and physically capable of participating in the 1, 5 or 10k run/walk. My participation is voluntary and is done at my own risk. I understand that participation in the "Family Fun Run" is an inherently dangerous activity and that risks of participating include, but are not limited to, the weather, to include high heat and humidity, conditions of the road and other race area surfaces, falls, collisions, motor vehicle traffic, and the conduct of spectators and other runners, I hereby, for myself, my heirs, my administrators and executors, personal representative and my assigns forever waive, release and discharge any and all rights and claims for damages or losses, whether monetary or otherwise compensatory, that I may have against: (i) Girl Scouts of Sierra Nevada Council, its directors executive director, officers, employees, members, representatives and agents; (ii) any sponsors of the race, their directors, executive director, officers, employees, member, representatives and successors; (iii) all "Family Fun Run" officials, participants, organizers, planners, and volunteers for any injuries sustained by me arising out of my association with, entry in, or participation in "Family Fun Run " and any pre-, post- or other race-related activity. I understand and agree that medical or other services rendered to me by or at the request of any of the above parties is not an admission of liability to provide or continue to provide any such services and is not a waiver by any said parties of any right hereunder. I also acknowledge that should I require transport to a medical facility, I must pay for such transportation and any treatment provided. I further agree now and forever to hold the above named and unnamed parties harmless and indemnify them for all claims, damages, judgments and costs of whatever nature and form. I agree to abide by all instructions from race officials and I agree to withdraw from the race if such official in his or her sole judgment and discretion determines that I should not participate because my participation poses a threat to the safety of myself or because I did not abide by any instruction given to me. I grant permission to Girl Scouts of Sierra Nevada Council and local media to use any photographs, videotapes, motion pictures, recordings or any other record of me and/or this event for any legitimate purpose. I understand that the race entry fee paid by or for me are non-refundable. The non-refund policy applies to any cancellation of the race for weather or other circumstance as deemed appropriate by the official race director.
